PLEASE READ AND INITIAL EACH SECTION *

I. DEPOSIT: Personal checks are acceptable for the deposit only and must be sent two weeks prior. Deposits are refunded if a client or our company cancels for Rain Only! 4 hour notice must be given. Client can reschedule for another date, subject to availability. If client doesn't cancel, and we show up, the deposit will be non-refundable. So-Cal Animals reserves the right to refuse service to anyone; in such case, the deposit will be refunded _____.

II. BALANCE PAYMENT: So-Cal Animals requires balance be paid in full upon arrival, prior to set up. If the purchaser is late in getting payment to a So-Cal Animals' representative, we will not be held responsible for late set-up of event. Acceptable forms of payment include: Cash, Cashier's check, money order or company checks (**No personal checks**) _____.

III. LATE PAYMENTS: It's mandatory we get paid for our service the day it is provided. Please don't say the check is in the mail. There is a \$50.00 late fee. No exceptions (unless prior arrangements have been made) _____.

IV. PARKING: So-Cal Animals will be provided convenient, close parking for our vehicles and trailers to our set up area, as we are constantly using our trailers for feed, etc. for our animals _____.

V. WEIGHT LIMIT: A 75 pound weight limit will be enforced for pony rides. If the purchaser needs to accommodate anyone over 75 lbs., then prior arrangements must be made to bring larger ponies (which we have available upon request) _____.

VI. CANCELLATIONS: If the purchaser needs to cancel engagement, So-Cal Animal Rentals must be notified within thirty days of engagement to insure rebooking. 20% of original balance cancellation fee will be charged if not notified within thirty days. A cancellation due to inclement weather is neither the fault of the purchaser nor So-Cal Animal Rentals, and no fee will be charged upon inclement weather cancellations, as long as it is agreed upon by both parties beforehand. If So-Cal Animal Rentals arrives at destination on purchaser's request, and it is then rained out, purchaser agrees to pay a 20% of balance trip charge to So-Cal Animals _____.
